## **Agreements:**

Until release of a Microsoft Generally Available product, Adxstudio Portals will continue to be available as a separate product via existing ADX agreements and processes. Purchase of Adxstudio software may not be completed on Microsoft contracts and Microsoft terms and conditions do not apply.

**Timing:** Adxstudio sales will continue to be available until Microsoft General Availability of a comparable product.

**Licensing & Deployment:** Existing Adxstudio options are as follows. There is currently no plan to include Adxstudio Portals with any existing Microsoft offers. 

# **CRM Licensing Requirements**

Access to CRM entities via a portal does not remove or substitute baseline CRM Licensing Requirements. Please refer to the Dynamics CRM Online Licensing and Pricing Guide for details (Page 4, 5 & 9 – Internal/External Users, Multiplexing, & Custom Entities). http://aka.ms/gtn5wt

Internal Users: Regardless of mode of access, internal users accessing CRM entities or data are required to have the appropriate USL, CAL, or SAL depending on the type of use (read/write) and entities involved.




Includes the organization's customers and suppliers not performing business processes on behalf of the organization (for example, supply chain vendors).

Internal User Examples:

Includes vendors performing business processes on behalf of the organization or integrated into the organization's operations.

- User is not a FTE of Microsoft customer, but has an agency or contract relationship. This user participates in the sales cycle on behalf of the Microsoft customer business. The agent is updating taking opportunities, calling prospects and writing an opportunity back into the system.
- User is not an FTE of Microsoft customer, but does contract work executing projects on behalf of the Microsoft customer.

Multiplexing also does not remove the need for a license for internal users.



Multiplexing does not reduce the number of USL's required.

Any future release of a Microsoft product based for portals scenarios will be considered as a different product with different terms and conditions.
