#### **DESIGN AND MANAGE A SAM PROGRAM**

#### **GETTING STARTED**

- The first step is to secure executive sponsorship for the SAM Program. This
  will include identifying stakeholders and creating proposal materials to ensure
  that there's explicit executive authorization for the SAM infrastructure with
  policies and overall corporate governance
- At this time funding should be secured by creating a project plan and budget
  where operational costs in both consulting hours and employee time are
  estimated so that funding can be obtained from each infrastructure group for
  each task associated with managing a SAM Program

#### SAM Program goals

- Identify resources and objectives
- Align with organization requirements

## Future plans and business goals

- Acquisition strategies
  - Is it the right time to consider an Enterprise Agreement? Pricing can be advantageous when all desktop PCs and servers are licensed with Microsoft software
- New technologies
  - Is the organization ready to increase their virtualized infrastructure? The MAP Toolkit can help plan for this
  - Should the organization consider SaaS and IaaS/PaaS solutions? Cloud licensing metrics are often simpler to manage and can provide cost savings by only paying for what is being used

## IMPLEMENT A SAM PROGRAM

 Create a SAM stakeholder group to oversee the project



- Assess and benchmark the current state of SAM
- Implement technologies to support asset discovery
- Enhance purchasing processes to include storage and retrieval of license entitlement information
- Perform initial license and cloud services reconciliation
- Create policies, processes, and procedures to support SAM efforts
- Secure support from all associated departments
- Educate employees



## MANAGE A SAM PROGRAM

- Monitor adherence to the policies, processes, and procedures of an organization's SAM life cycle
- Standardize SAM processes across all domains and organizational units



Provide ongoing SAM awareness training
