Licenses added at the start of the year are paid for upfront for the whole year. Licenses may be added via the License Reservation process during the year and paid for at Anniversary.

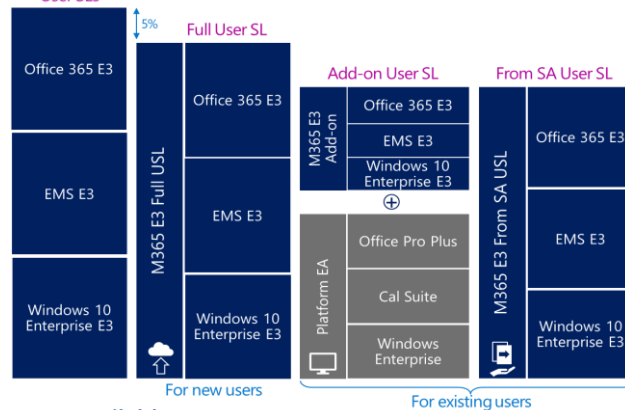

## Licensing Microsoft 365 E3/E5

Individual component  
User SLs



All of the licenses shown are also available for Microsoft 365 E5 and its components. Customers with Microsoft 365 E3 User SLs may purchase a Step-up to Microsoft 365 E5, or to the individual E5 components.

### Licenses available:

#### Microsoft 365 E3/E5 Full User SL:

- Use at any time to add new users to an existing EA; or
- Use when a customer signs a new EA and wants to license users rather than devices

#### Microsoft 365 E3/E5 Add-on User SL:

- Use at any time to preserve an existing Professional or Enterprise Desktop licensing position and to license some or all users for the products on a user basis
- The number of licenses may be reduced at Anniversary

#### Microsoft 365 E3/E5 From SA User SL:

- Use at Anniversary or Renewal to move users with fully-paid Professional or Enterprise Desktop licenses to a user licensing model
- Customers who have paid for subscription licenses for three years through an Enterprise Subscription Agreement are also eligible for these licenses
- From SA licenses may be renewed at subsequent EA Renewals

### Office Professional Plus rights

The following rights are available for active SA customers when transitioning to Microsoft 365 E3/E5 using From SA User SLs purchased through an Enterprise Agreement:

#### Office Professional Plus

- One installation for the term of the Microsoft 365 E3/E5 Subscription
- Downgrade rights are included
- Rights to run Office Professional Plus in an RDS deployment are not included

Customers who add new Microsoft 365 E3/E5 Full User SLs to the same Volume Licensing agreement as the one through which the From SA User SLs are purchased, also receive the rights to install Office Professional Plus.

The number of Full User SLs which are granted these rights may not exceed the initial number of From SA User SLs.

### Server installation rights

Customers with Microsoft 365 E3/E5 User SLs (or the three components) may install unlimited copies of Exchange Server, SharePoint Server and Skype for Business Server. Current or previous versions may be installed on a server dedicated to the customer's use provided by the customer or an Authorized Outsourcer.
