

Licensing Dynamics 365 Fraud Protection

Dynamics 365 Fraud Protection helps block fraudulent activity with a complete set of protection and prevention capabilities:

- **Account Protection (AP):** Assesses online account events (creation, login, activity) for fraud or abuse
- **Purchase Protection (PP):** Assesses online payment transactions for fraud
- **Loss Prevention (LP):** Protects online or in-store transactions by identifying potential fraud on returns and discounts



Dynamics 365 Fraud Protection licensing overview

1. Choose a single base capability license which costs \$1,000 per month. The base capability licenses each include a transaction allowance for all three of the Fraud Protection capabilities as shown in the table below. For instance, the Account Protection base offer includes 100,000 Account Protection transactions, 2,000 Purchase Protection transactions, and 4,000 Loss Prevention transactions:

2. Purchase overage add-ons for extra capacity as shown in the table below. Any add-ons may be purchased with any base offer:

	AP	PP	LP
Included transactions	20,000	2,000	4,000

Overage add-ons cost \$150 per month, unless the minimums below can be met when Tier 2 pricing at \$100 per month becomes available:

	AP	PP	LP
Minimum transactions	2,000,000	500,000	250,000
Minimum SKUs	100	250	63

Fraud Protection licensing example

- Contoso Ticketing Master want to protect their business from credit card payment fraud and will use the Purchase Protection (PP) capability with an estimated **25,000** transactions per month
- They purchase the Purchase Protection base offer which includes **10,000** PP transactions per month
- Their overage requirements are **25,000 – 10,000 = 15,000** transactions per month
- The PP overage add-ons include **2,000** PP transactions per month
- They purchase **15,000 / 2,000 = 8** PP overage add-ons at Tier 1 pricing per month

Dynamics 365 Fraud Protection pay-as-you-go (PAYG)

Alternatively, customers can pay for their transactions on a PAYG basis each month. There's a fixed monthly fee of \$12 per tenant per month, and when PAYG billing is enabled in the Fraud Protection portal it's paid for through a nominated Azure Subscription. Dynamics 365 Commerce + Fraud Protection

Dynamics 365 Commerce licenses include Fraud Protection transactions:

- **Account Protection:** 20,000 transactions per month
- **Purchase Protection:** 2,000 transactions per month
- **Loss Prevention:** 8,000 transactions per month

Additional transactions are then purchased via the usual overage add-ons with no requirement to purchase a Fraud Protection base offer license.
