These are license-based services with User Subscription Licenses assigned to individual users.

Use rights for the Online Services are detailed on the Product Terms website.

Customers accept the terms of the Microsoft Customer Agreement which may customize terms for products acquired through CSP.

## Windows 11 Enterprise

Available Windows 11 licenses:

Windows 11 Enterprise E3 User SL Windows 11 Enterprise E5 User SL Must be assigned to a user whose primary work device is licensed with Windows 11 Pro



Use rights of Windows 11 Enterprise E3/E5 Users SLs:

- Windows 11 Enterprise E3 and E5 licenses include an upgrade to Windows 11 Pro from Windows 8, 8.1 or 10
- If a Windows 11 Enterprise E3/E5 subscription is not renewed, there is a 90-day grace period and then Windows is rolled back to Pro functionality
- Rights to Windows 11 Pro on upgraded machines are • perpetual
- Windows 11 E3/E5 may be installed on up to 5 devices or virtual machines
- No rights to previous versions, or rights to Windows 10 Enterprise LTSC
- No Software Assurance benefits
- No re-imaging rights
